FEEDBACK FORM

Green GEN Cymru is consulting on updated proposals for a new 132 kV electricity connection to transport energy to the national electricity network. This is part of our mission to help deliver renewable energy across Wales to our homes, businesses, and communities.

The proposed Green GEN Towy Teifi connection will connect proposed energy developments in Ceredigion to a new National Grid substation at Llandyfaelog, Carmarthenshire.

The connection is approximately 52km in length, consisting of steel lattice pylons and two sections of undergrounding, one at Merlin's Hill and another at Llandyfaelog.

Following careful consideration of feedback on our first consultation, and further technical and environmental assessments, we have developed a draft route alignment, showing proposed locations of the infrastructure we need. For this consultation we are asking for your feedback on:

- Proposed infrastructure included as part of our draft route alignment, including pylon locations and sections of undergrounding.
- Any other information or impacts we should consider when reviewing and developing our proposals.

We have published a suite of information about our proposals to support you in providing feedback. We encourage you to read these materials before completing this form. These documents are available, along with further information and an interactive map on our website www.greengentowyteifi.com

We are focused on delivering a project that best works for those who live, work and enjoy recreation close to our proposals. We are committed to protecting the surrounding environment.

We know that people have different views on new infrastructure, and we recognise people have concerns about pylons featuring in the landscape. Delivering the infrastructure we need to add grid capacity, address climate change, and help the country transition to electric vehicles and heating requires a careful balance.

Feedback is playing a key role in how we develop the project. Local knowledge can help us understand any potential effects and benefits that we may not have considered in our work to date and will inform our work going forward. Please provide as much detail as you can when giving feedback including, if possible, specific pylon numbers. These can be found on the interactive map on our website.
